**Purchaser agrees that it shall not resell tickets to the general public or to any person or entity at a price exceeding the actual cost to Purchaser. Purchaser further agrees that the Great Value Tickets are for approved businesses/organizations to issue as a gift or may resale at original purchase price to approved organization members or approved business employees or for promotional purposes that have been preapproved by Great Escape Theatres. Great Value tickets may not be used for a single group showing, contact local theatre manager for separate pricing and possible reservation.

Purchaser agrees that it shall have no rights against Great Escape Theatres from the purchase of Great Value Tickets other than reimbursement of their purchase price in the event of a breach of Great Escape Theatres' obligations herein.

Any breach of these rules will immediately invalidate all of the Great Value Tickets purchased hereby, result in forfeiture of their purchase price or admission rights, and subject Purchaser to legal action.

These Terms & Conditions may not be amended with respect to any order that has been placed, except in writing by a duly authorized representative of Great Escape Theatres. These Terms & Conditions may otherwise be amended at any time by Great Escape Theatres' in its sole discretion upon written notice to Member; any such amendment shall apply only to order placed after the date of such written notice.

If any portion of these Terms & Conditions is held to be illegal, invalid or unenforceable in any respect under any present or future law or if determined by a court of competent jurisdiction to be unenforceable, such provision shall be fully severable, and these Terms & Conditions shall be construed and enforced as if such illegal, invalid or unenforceable provision had never comprised a part of these Terms & Conditions, and the remaining provisions of these Terms & Conditions shall remain in full force and effect and shall not be affected by the illegal, invalid or unenforceable provision or by its severance from these Terms & Conditions.
